## Nominations Wanted!

It is that time of year again to recognize our region's top-performing companies! Now in its 24th year, the ACCGS is seeking nominations for its Super 60 program to be held October 25, 2013 at 11:30 a.m. at Chez Josef in Agawam.



The program celebrates the success of the fastest growing, privately held businesses in the region which make significant contributions to the strength of the regional economy.

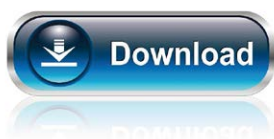
To be eligible, companies must be:

- Independent and privately-owned;
- Have revenues of at least \$1 million in the last fiscal year;
- Be based in Hampden or Hampshire Counties or a member of the ACCGS; and
- Have been in business for at least 3 full years

Companies will be honored for percentage of revenue growth over a full 3-year period OR total revenues for the latest fiscal year.

Companies may be nominated by financial institutions, bankers, accountants, attorneys or be self-nominated. Nominees must provide net operating revenues for the last three full fiscal years, verified and signed by an independent auditor. All financial information must be reported under generally accepted accounting principles, will be held and considered confidential and will not be released without prior approval.

**Deadline for nominations is August 23, 2013.** Download the nomination form and help us celebrate the strength of our region!



## New Tax Bill Approved

The Massachusetts Legislature has approved legislation that will raise taxes \$500 million in taxes to invest in transportation and infrastructure in the Commonwealth.

What does that mean to you? Among the changes that will take effect on July 31, 2013 are:

**Gas tax:** A 3 cent per gallon increase, raising that tax to 24 cents per gallon, the indexed to inflation on January 1, 2015 and yearly after that.

**Cigarette Tax:** Retailers will see the cost of a pack of cigarettes increase by \$1, raising that tax to \$3.51 per pack. In addition, taxes will increase on smoking tobacco, cigars and smokeless tobacco products.

**Computer and software services:** This is a new tax that expands the sales tax onto computer system design and to modification, integration, enhancement, installation or configuration of standardized or pre-written software.

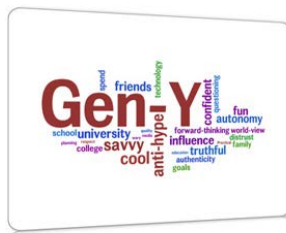
While the ACCGS recognized the vast amount of infrastructure needs, having to look no further than the \$ 450 million project to rebuild the elevated section of I-91 through Springfield, the Chamber supported a reasonable bill. However, the computer and software services tax in the final bill is troubling to the ACCGS and work is underway to have the language corrected.

The ACCGS believes that the final language is so broad that it will hit virtually every sector of technological services and especially those involved in the innovative sectors of our economy. The Department of Revenue (DOR), who collects these taxes, has a track record of broadly interpreting legislation, and we fear this will happen again. Even the agency's own Web site notes the agency is struggling with making sense of the issue and that final regulations may not be written until October.
