State Street Unveiled

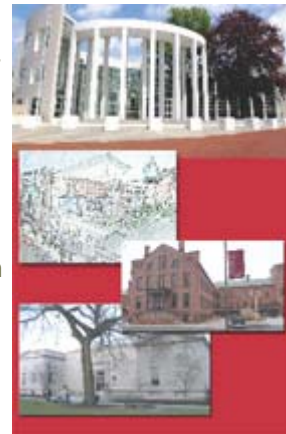
