President's Message

Well our 2013-2014 Chamber season has come to a close, capped off by a great Annual Meeting on June 27. We had much to be proud of this Chamber season. Here are just a few successes in case you missed the event:

Despite an economy still recovering, our membership remained stable at 912 strong, and the percentage of members that remain with the chamber year after year is above the national average for chambers of our size and demographics.

We launched four new programs to meet the niche needs of our members, reinvigorated our After 5's and beefed up our Business@Breakfasts - and all met with overwhelming success.



With education and workforce development critical to our region, our affiliate, the ERC5, provided \$14,000 in financial support to assist the schools and students in the five communities it serves, and our PWC affiliate provided scholarships to non-traditional women returning to college to empower them and provide increased opportunities for career advancement.

We successfully advocated for the continuation of the health insurance cooperative, allowing small businesses to band together as one to reduce the cost of purchasing health insurance. To that end, our Springfield Chamber affiliate launched a new fitness benefit with the newest downtown Springfield business, 180Fit Gym at a savings of 30%! And ERC5 members can save an Alexander Hamilton - or \$10 - off the monthly fee at the East Longmeadow Healthtrax.

We once again were successful in retaining a single tax rate in all five of the ERC5 communities and a fair split in the City of Springfield.

The Springfield Chamber reintroduced its recommendation for a mayoral salary increase, which will allow the City to be able to effectively draw and compete for the highest caliber of mayoral candidates - experienced individuals with a proven talent in solving the most complex problems and making critical and, at times, unpopular decisions. That recommendation passed and was enacted January 1.

Once again, we were successful in our advocacy for a freeze in the unemployment insurance tax rate, preventing a 30% increase in rates in 2014 which would have added an estimated \$500 million to employer UI costs. And, we were one of only 10 signors and on of only two chambers of commerce to support the successful petition to repeal the so-called "tech tax," a sales tax on technology that would have crippled our region's technology sector.

And we have been successful in our efforts against a rapid and steep increase in the minimum wage and ensuring it not be tied to future increases to inflation. And we have been successful in ensuring that IF a wage increase was adopted, that increase MUST be coupled with unemployment insurance reforms.

We continue to oppose efforts to mandate paid sick leave, mandate a nurse-patient ratio, limit hospital margins and cap CEO compensation. We may see some of these on the November ballot, and we urge you to vote against them.

While our accomplishments have been great, I must admit the icing on the cake was the ACCGS being named by members and the public alike as the Best Chamber of Commerce in *The Republican*/MassLive Reader Raves online poll. THANK YOU!

AARP recently named Springfield one of the top ten small cities for retirement. It noted the city's culture, educational opportunities for retirees, historical sites, and outdoor recreation for its placement on the list, specifically highlighting the five world-class Springfield Museums, the Dr. Seuss National Memorial Sculpture, Springfield Symphony Hall, CityStage, the Five College Learning in Retirement, Springfield College's Learning in Later Life, boating, fishing, hiking and golfing.

Springfield joined Burlington, VT; Athens, GA; Bellingham, WA; Portsmouth NH; Bloomington, IN; Winchester, VA; Corvallis, OR; Napa, CA and Lewiston, ME on the list.

ESE Significant Contributor to Region's Economy



In a recent study conducted by the Regional Economic Models, Inc. (REMI) of Amherst, MA, Eastern States Exposition attracts more than 2.5 million people to its 120 year-round events including 1.4 million visitors to The Big E, the fifth largest fair in North America, contributing \$479 million in overall economic impact with a Gross Regional Product (analogous to the national Gross Domestic Product) of more than \$299 million annually.

Among the other findings in the report, the Exposition:

- Accounts for 3,000 jobs in Hampden County
- Generates \$91.9 million in personal income
- Adds \$1.4 million to the Massachusetts sales tax revenues
- Generates \$427,000 in hotel tax revenue
- Generates \$3 million in income tax revenue
- Represents \$3.3 million in food and beverage tax revenue
- Represents 4.9% of all Hampden County performing arts and spectator sports spending
- Generates 11.5% of the annual sales in the accommodations & food services & drinking places sector

Calling All Artists

The Springfield Museums have received a \$5,000 grant from the Xeric Foundation to present *Art Picnic*, a public arts project designed to beautify Springfield and give local art students from Distinctive Art Studio the chance to collaborate with established artists. The project will help to boost the creative economy of Springfield by providing a vehicle for local artists to display their work, while also allowing local art students to expand their skills, build their resumes and feel motivated to pursue a career in the arts. *Art Picnic* was first launched in the summer of 2014, when over 24 artists and students worked to create unique artwork on tables at the Museums.



For this year's project, four picnic tables on the Quadrangle green will be transformed into unique works of art through a selective process that is scheduled to begin later this month. Phase one of the project involves a call to local artists to submit original mural designs for consideration by an advisory panel led by Heather Haskell, Director of Art Museums and Collections, Rosemary Tracey Wood, owner of *Art for the Soul* Gallery, Evan Plotkin, arts advocate and president of N.A.I. Plotkin, and Don Blanton, former *Art Picnic* participant and winner of the People's Choice Award. The advisory panel will select the four designs, and the winning artists will receive a stipend of \$1,000 to cover the cost of their time and materials. ***The deadline for submitting designs is July 11, 2014*** - complete information is available on the Museums [Web site](#).
